OUR MAIN EMPHASIS IN 2018 WAS OUR LOW COST SPAY/NEUTER CLINIC. THE CLINIC IS OPEN TO THE PUBLIC AND OFFERS HIGH QUALITY, HIGH VOLUME, LOW COST SPAY AND NEUTER SURGERIES TO DOGS AND CATS. WE ALSO OFFER LOW COST VACCINATIONS, FLEA AND TICK MEDICINE, HEARTWORM TESTING, MICROCHIPPING AND LIMITED ADDITIONAL VETERINARY SERVICES THROUGH OUR WELLNESS CLINIC. IN 2018 WE PERFORMED 11,723 SURGERIES, AND HAD A TOTAL OF 7,506 WELLNESS CLINIC VISITS. OF THE TOTAL SURGERIES PERFORMED, 5,294 WERE SHELTER PETS AND 2,915 WERE COMMUNITY CATS. IN ADDITION, WE PROVIDED FINANCIAL ASSISTANCE TO 3,166 PET OWNERS WHO COULDN'T AFFORD OUR ALREADY LOW PRICES.
