IN AN EFFORT TO REDUCE PET OVERPOPULATION AND PREVENTABLE EUTHANASIA IN OUR COMMUNITY, OUR CLINIC IS OPEN TO THE PUBLIC AND OFFERS HIGH QUALITY, HIGH VOLUME, LOW COST SPAY AND NEUTER SURGERIES TO DOGS AND CATS. WE ALSO OFFER LOW COST VACCINATIONS, FLEA AND TICK MEDICINE, HEARTWORM TESTING, MICROCHIPPING AND LIMITED ADDITIONAL VETERINARY SERVICES THROUGH OUR WELLNESS CLINIC. IN 2019 WE PERFORMED 12,220 SPAY/NEUTER SURGERIES, AND PROVIDED SERVICES TO A TOTAL OF 8,396 IN OUR WELLNESS CLINIC.
