

# Trap Rental Agreement

This Trap Rental Agreement serves as a binding contract for equipment rental services provided by Humane Fort Wayne for the purpose of trapping cats. Rental equipment is intended **only for cats** and may not be used for any other animal species or wildlife.

\_\_\_\_ I understand that by signing this agreement, I am responsible for the location and condition of the trap(s) and will return them undamaged.

\_\_\_\_ I understand that I am responsible for monitoring any cat(s) that I trap and will monitor the live trap(s) throughout the entire TNR process. Failure to do so may result in injury or death to the animal and may constitute a violation of Fort Wayne City Ordinance § 91.026 regarding Animal Abandonment.

\_\_\_\_ I agree to return the live/drop trap within **one week** of the rental date. Due date: \_\_\_/\_\_\_/\_\_\_\_. If the trap is returned after the due date, an additional **\$50.00 late/replacement fee** will apply. If the card on file is declined, I understand I will not be eligible for future services through Humane Fort Wayne until the fee has been paid or the trap has been returned.

\_\_\_\_ I understand that a **\$70.00 deposit** per trap is required at the time of rental. The rental fee is **\$10.00 per day**. If the trap is returned before the end of the seven-day rental period, the unused portion of the deposit will be refunded. If the trap is not returned, or if it is lost, damaged, or stolen, I will forfeit my **\$70.00 deposit**, and an additional **\$50.00 replacement fee** will be charged to the card on file.
